4. All State/ All Star updates

- a. Proposal sent to OCA, Dozier inquired regarding Cross Country as well as Track (proposed). Dual proposal added to their May 4 Agenda. Proposal passed. All State is not dependant upon Senior Status.
 - i. Track
 - 1. 1st Place = OCA All State
 - 2. 2nd-3rd Place =OCA All Star
 - ii. Cross Country
 - 1. 1st-10th = OCA All State
 - 2. 11th-15th = OCA All Star
- 5. Board Seat for Track Seat 1 is expired (effective June 1).
 - a. Protocol: position is open for applications. Expiring seat holder may apply.
 Application link will be posted on OHStrack.com in the OCCTCA Officers
 Tab (left hand side of the webpage).
 - b. Duration of application; Application Link will be live June 3 through June 28 (12:00pm)
 - c. Duration of election; Election Link will be live July 1 through July 7 (12:00pm).

6. Meet of Champions

- a. Track & Field Meet of Champions
 - i. Thank you to Stroud Public Schools & Coach Kelly Brown
 - ii. Participation: 233 (last year under 200)
 - iii. Discussion on things to adjust:
 - 1. Uniform Tops will rotate colors, athletes who qualify multiple years will not have identical tops.
 - 2. Meet Records will be published with Meet Information.
 - 3. Field Events will begin at 11:00am, Check-In beginning at 10:00am.
 - 4. Move 400 Meter race to 11:00am start (Check-In at 10:00am), in an effort to provide athletes who qualify in multiple events ample recovery time.



- 5. Running Events will begin at 1:00pm, no change
- 6. Medal 1st-6th place in individual and relay events.
- 7. OCCTCA All-State Patch 1st-3rd place & eligible to purchase OCCTCA All-State Jacket.
- b. Cross Country Meet of Champions
 - i. Combined with the Oklahoma-Arkansas All-Star this year.
 - ii. Location: Broken Arrow Cross Country Course
 - iii. Discussed Items
 - 1. Medals 1st-25th place per race.
 - 2. OCCTCA All-State Patch for top 10 Oklahoma finishers per race.
 - 3. Qualifying Criteria (modified due to the addition of Class A)... Top 5 per class, eligible individuals must have placed top 10 in their respective State Championships.
 - a. In the event 5 positions per class are not filled...
 - 4A & Below next best times/ athletes will be selected from those 4 classes (due to girls running 3200 meter race and continuity between genders) for remaining available positions.
 - ii. 5A & 6A next best times/ athletes will be selected from those 2 classes for remaining available positions.

7. Senior All-Star

- a. Certificates printed, board members addressed to the recipients schools, and will be mailed next week.
- b. We will continue to select All-Star Senior recipients automatically, with preliminary rosters posted to our Facebook page with non-member athletes highlighted; giving coaches the opportunity to pay membership dues before their athlete is overlooked.



- c. Discussion/ Action to modify the selection since OCA has approved the proposal to extend recognition for All-State/ All-Star.
 - i. Track & Field: OCCTCA Senior All-Star, State 4th-8th place.
 - ii. Cross Country: OCCTCA Senior All-Star, top 10 Seniors not placing in the top 15 at the State Championship.
 - iii. OCCTCA Senior All-Star amendments: Passed (9-0)

8. OSSAA XC updates

- a. State @ Edmond Santa Fe
 - i. Working on modifying the time schedule
 - ii. Parking should be less of burden with smaller fields
- b. Class A; proposal approved

9. OSSAA Track updates

a. Regional Meets ran as Timed Finals, suggested schedules have been sent out from Brian Lester. Correspondence and discussion continues.

- Milesplit, performance rankings (will ask Milesplit for Coach access to <u>ALL</u> performance rankings, eliminate the pay wall).

 - Present during both Summer and Winter Clinics for Round Table Discussion/ Advisory Meeting (Summer) and Advisory Panel (Winter).
 - Publish Weekly Performance Rankings (can use all resources available: OHS Track Results, Athletic.net, Milesplit Rankings, etc...)
 - iii. Propose suggested regional assignments (send all information to Brian Lester). Goal is to split equally the top 4 tier, mid 4 tier and



the lower tier, then work geographically and with respect for both genders.

- iv. Any item(s)/ issue(s) that need addressed need to be:
 - 1. Written as a proposal (start sooner in season, don't wait until the week of the Advisory Meeting).
 - 2. Emailed to Brian Lester
 - 3. Then the proposal will appear as an action item and not a discussion item.
- c. Selection Process
 - Applications will be accepted, coaches from each respective class will vote for their Advisory Member (ie, Class 3A will be selected by 3A membership coaches).
 - ii. Men's Cross Country will be selected this summer.
 - iii. Any vacated positions in Womens Cross Country, Mens Track and/or Womens Track will be applications will be accepted at this time as well.
